Since 1998, we have completed more than **2,000** appointments across the UK and Germany covering all key sectors.

2018 saw a **14%** increase in the number of assignments on 2017 figures. Industrial, TMT and Support/Business Services were our strongest sectors.

The number of retained search assignments from medium-sized businesses remained strong at **60%** broken down as follows: 70% PE-backed, 19% privately-owned, 11% listed.

Assignments from PE Houses looking for board level talent and due diligence support ahead of a deal increased **25%** on 2017 figures.

Role focus remained a mix of Chairman/NED (29%), CEO/MD (23%) and CFO (26%). Demand for other critical positions including COOs, Sales/Marketing Directors, Commercial Directors, HR Directors and CTOs increased **22%** on 2017 figures.

Across 2018, our German practice contributed **40%** of our total business.

Demonstrating a strong regional focus, **80%** of UK assignments were for businesses headquartered outside London as follows: 31% South, South East, South West / 28% North / 21% Midlands, East.
