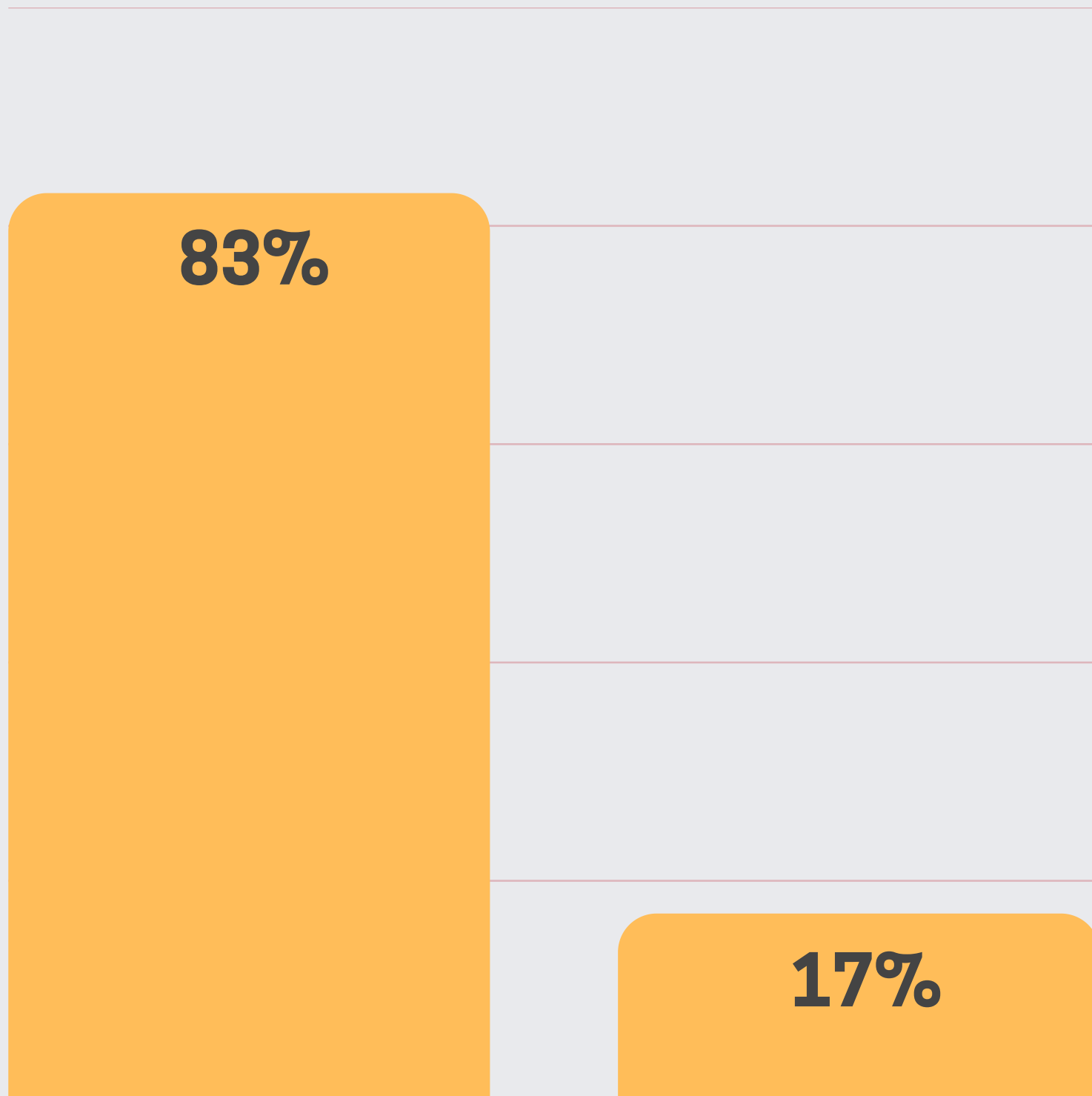

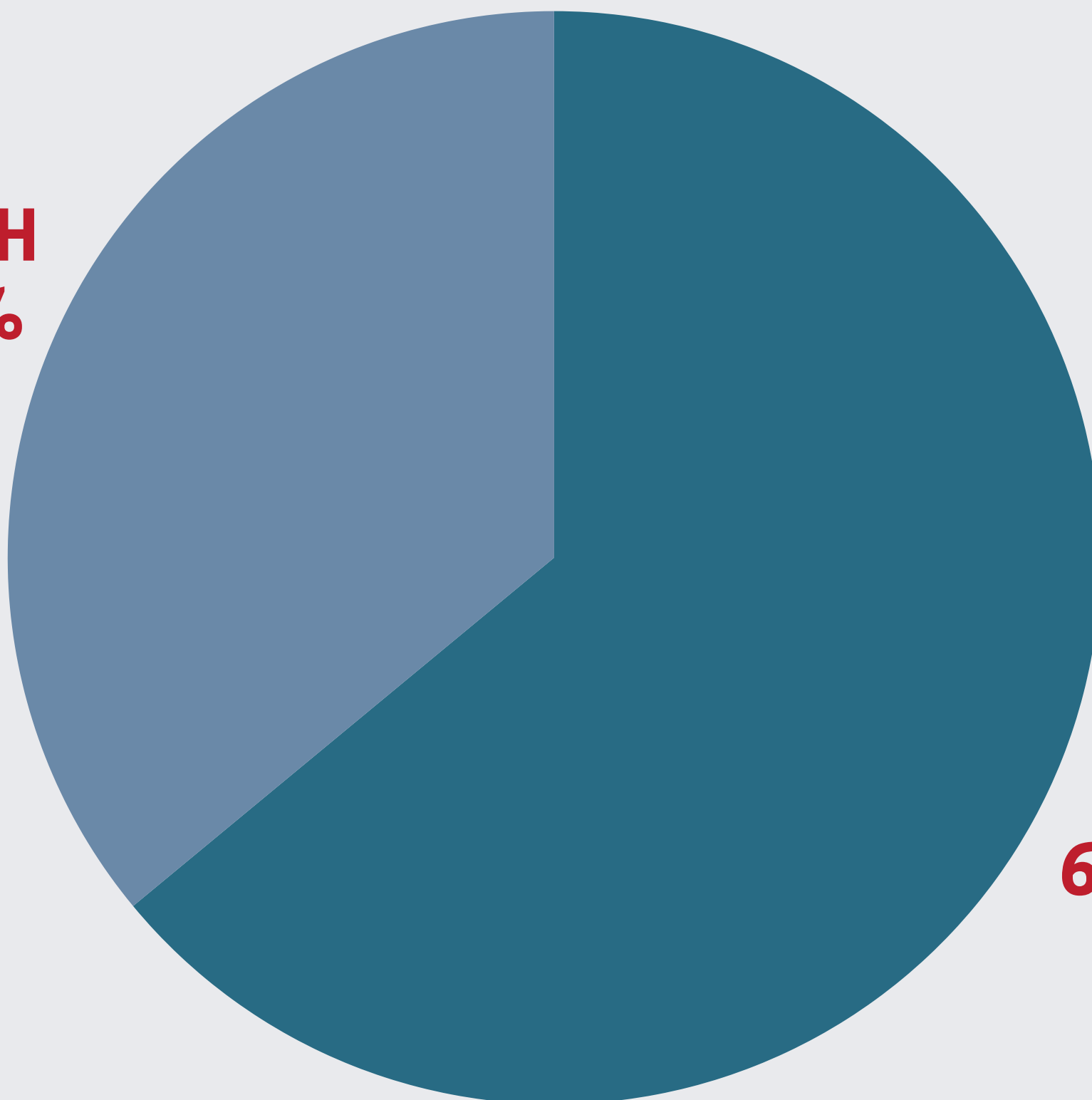

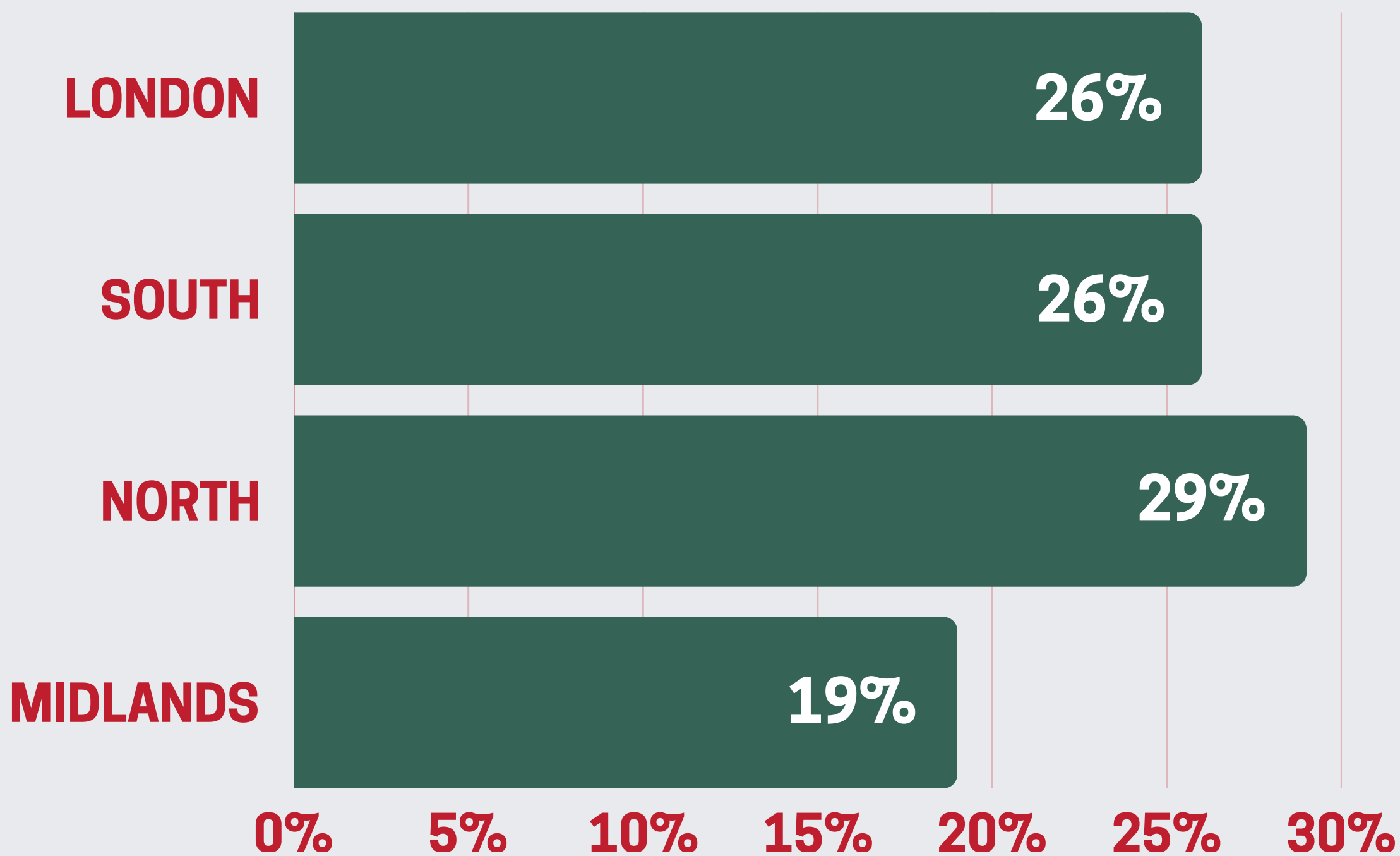

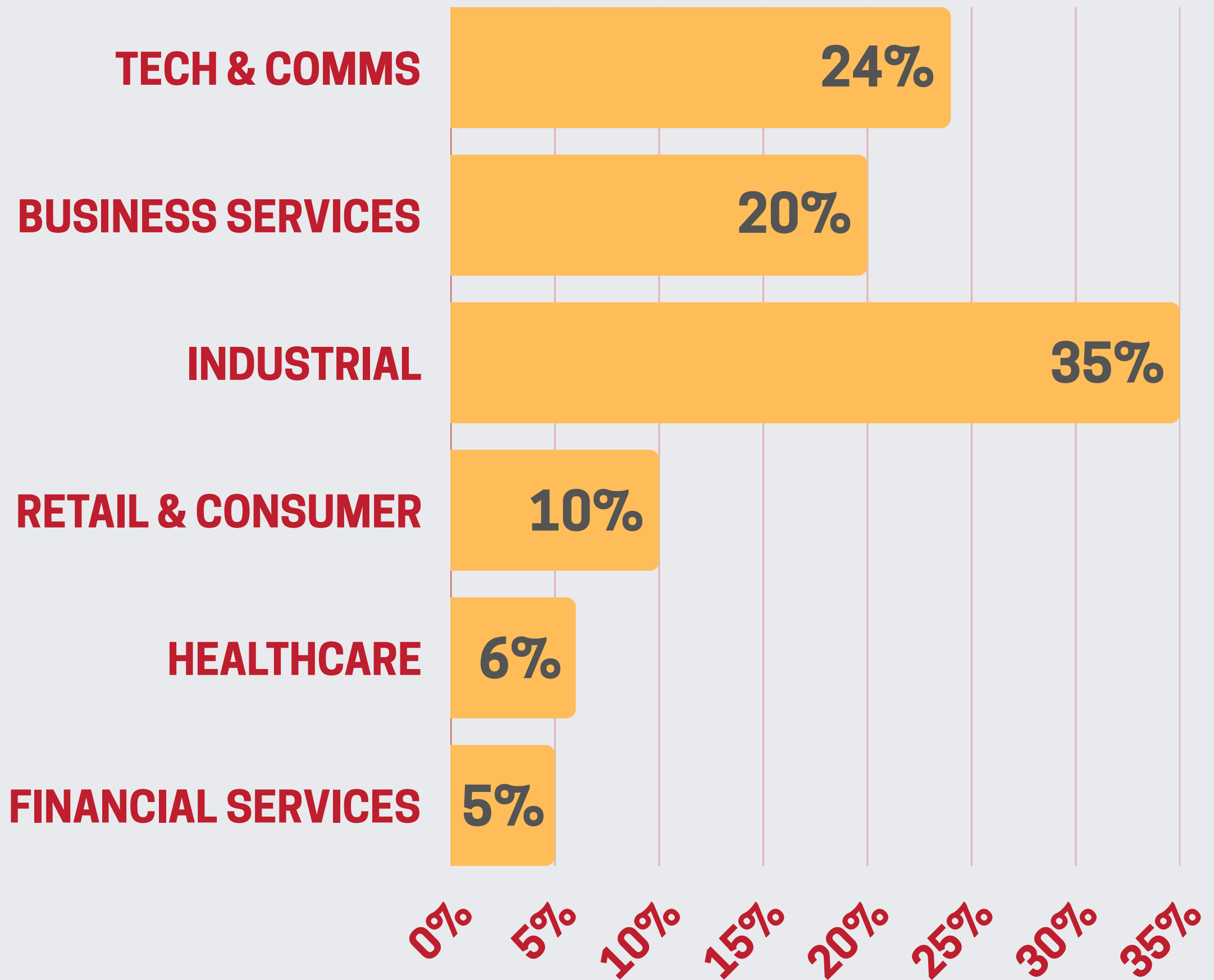

ACTIVITY BY UK REGION.



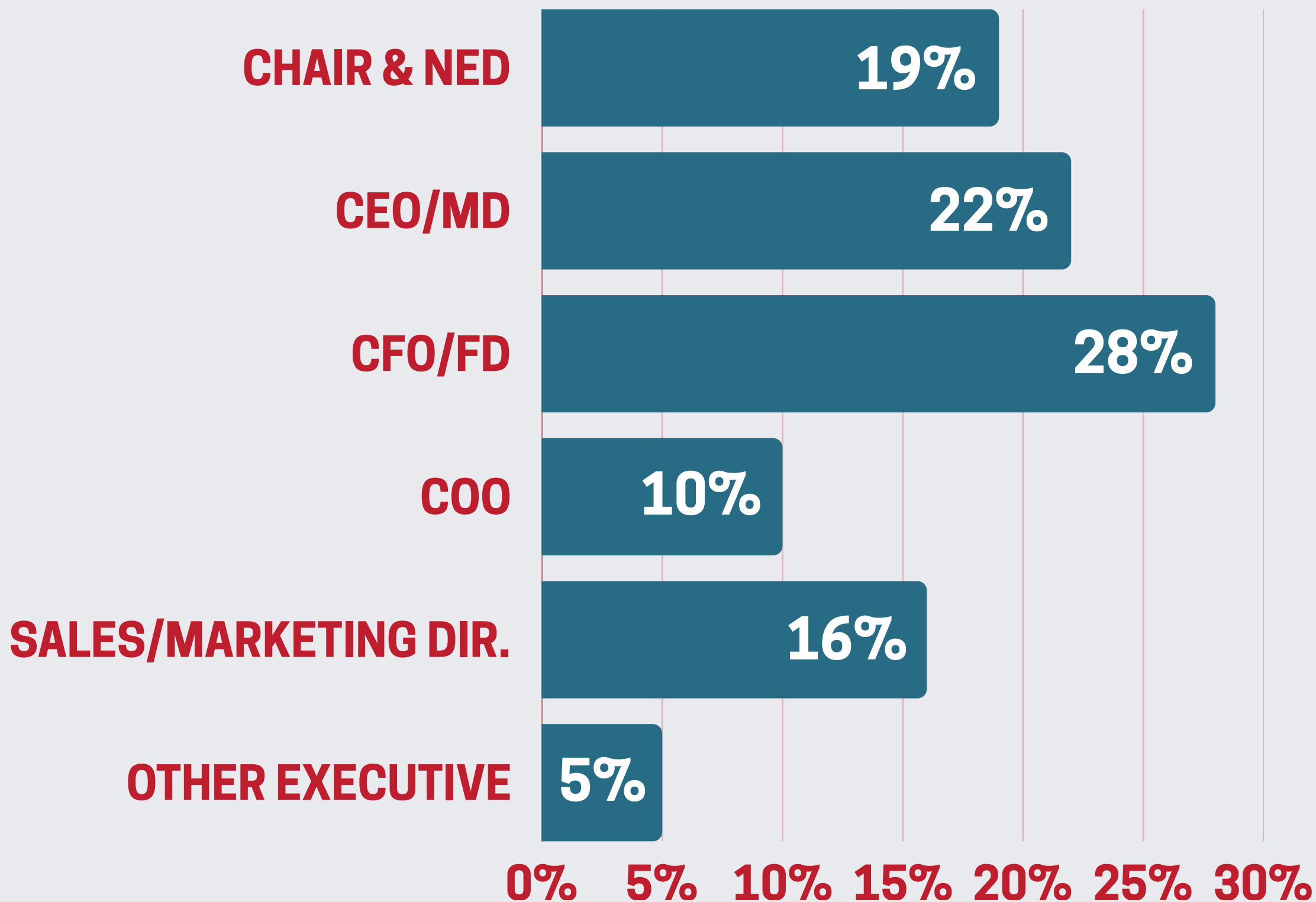

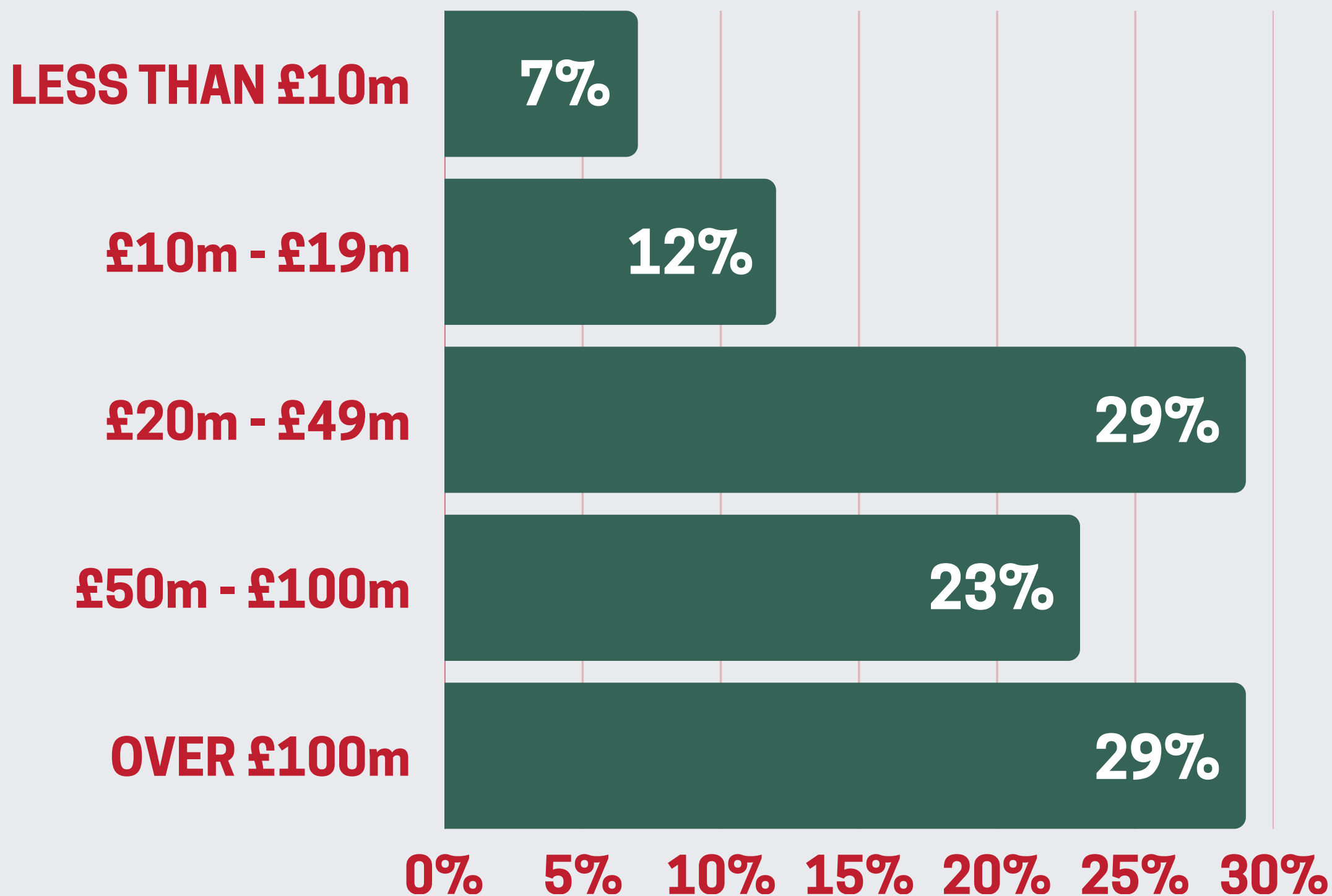

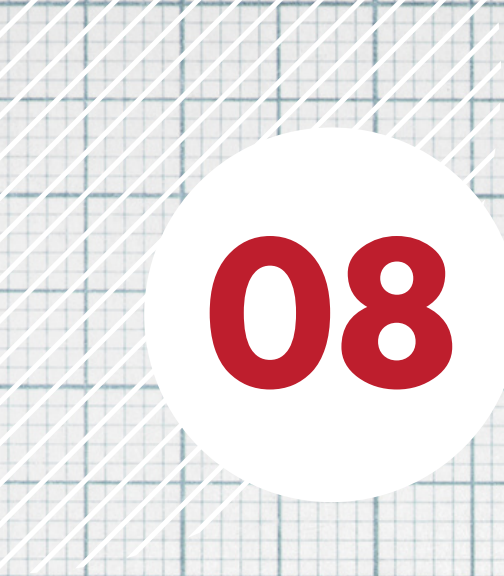
